

TWP Passive Balanced

Portfolio Objectives

Titan Square Mile aims to manage the portfolio to a volatility range of between 9.1% and 10.7% over rolling 10 year time periods. This is not guaranteed and actual volatility may fluctuate outside of these boundaries. The portfolio will be predominantly invested in equities, with some exposure to fixed income and other defensive assets. Equity exposure will range between 53% and 68% at the time of investment.

Commentary

The second quarter was characterised by persistent inflation, uncertain central bank policy and moderate, but slowing, economic growth. Markets were volatile, driven by elevated energy prices and geopolitical tensions, before stabilising towards the end of the period. Against this backdrop, equity markets delivered positive returns, led by the US, Asia and the Emerging Markets and specifically the technology sectors, while bonds faced a more challenging environment as rate expectations shifted. Portfolio performance benefited from strength in global equities and the advantages of a disciplined, well-diversified approach across asset classes and regions. Positioning remained largely unchanged during the quarter, with a continued focus on quality investments, liquidity and maintaining a balanced allocation to support resilience in uncertain conditions.

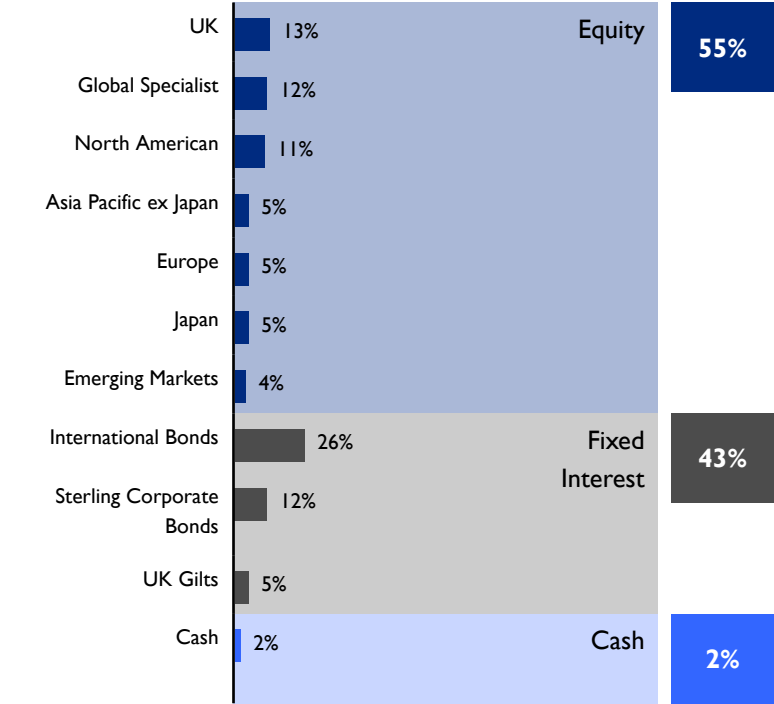
