Portfolio Objectives

Titan Square Mile aims to manage the model portfolio to an estimated volatility range between 12.3% and 13.9% p.a. over a market cycle. This is an estimation driven by capital market assumptions, and therefore not an annual guarantee as market movements may drive different outcomes in the shorter term. The Portfolio will be managed using Titan Square Mile's Growth 6 strategic asset allocation which has a 88% weight to equities. The portfolio will be predominately invested in a mix of equities but will hold a smaller allocation to fixed income and other defensive assets. The total equity exposure can range between 78% and 93%, at the time of investment. The portfolio may invest in funds managed by firms within the Titan Wealth Group. Titan Investment Solutions Ltd is a wholly owned subsidiary of Titan Wealth Holdings Ltd, part of the Titan Wealth Group.

Commentary

The second quarter was characterised by persistent inflation, uncertain central bank policy and moderate, but slowing, economic growth. Markets were volatile, driven by elevated energy prices and geopolitical tensions, before stabilising towards the end of the period. Against this backdrop, equity markets delivered positive returns, led by the US, Asia and the Emerging Markets and specifically the technology sectors, while bonds faced a more challenging environment as rate expectations shifted. Portfolio performance benefited from strength in global equities and the advantages of a disciplined, well-diversified approach across asset classes and regions. Positioning remained largely unchanged during the quarter, with a continued focus on quality investments, liquidity and maintaining a balanced allocation to support resilience in uncertain conditions.
