What is this product?

Type:

The Fund is domiciled in Ireland and is an open-ended investment company and qualifies as an undertaking for collective investment in transferable securities ("UCITS").

Term:

The Fund does not have a fixed term of existence or maturity period but in certain circumstances, as described in the Prospectus, the Fund may be unilaterally terminated following written notice to investors subject to compliance with the Prospectus and applicable regulation. Subject to the liquidation, dissolution and termination rights of the Board of the ICAV as set forth in the Prospectus, the Fund cannot be automatically terminated.

Objectives:

The Fund aims to achieve capital protection and capital appreciation by providing a return against the Bank of England UK Base Rate ("Benchmark") of +0.5% on a rolling 1 year basis.

The Fund is actively managed and will invest in fixed income securities listed or traded on Recognised Exchanges worldwide. The investments of the Fund represent a fixed income credit portfolio. Fixed income is defined as a corporate or asset backed securities.

The core focus of the fund is to invest in government and/or corporate Investment Grade ("IG") securities, including fixed and/or floating rate debt securities.

There will be no leverage or short positions in the Fund.

The Fund will have a maximum duration of 1.5 years. Duration is the price sensitivity of the fixed income securities in the Fund to changes in interest rates, expressed as a number of years.

At least 25% of the Fund's portfolio will be invested in securities which have final legal maturity within 1 (one) year.

All fixed rate securities must have expected maturity date of 3 (three) years or less. All floating rate securities must have expected maturity date of 5 (five) years or less.

The Fund may invest up to 100% of its Net Asset Value in government and/or corporate fixed income securities which are classified as Investment Grade ("IG") which means that securities have a credit rating AAA to BBB-.

At least 50% of the Fund's portfolio will be invested in securities rated AA on average and at least 25% will be invested in AAA. Ratings will be determined by taking the average rating from Standard & Poor's, Moody's, Fitch or any other equivalent recognised rating agency.

The Fund may invest in covered bonds which are bonds issued by a bank or mortgage institution and collateralised against a pool of assets that, in case of failure of the issuer, can cover claims at any point of time.

Depending on the market conditions, the Fund, where considered appropriate by the Investment Manager, may be wholly invested in cash deposits and money market instruments.

The Fund may utilise derivatives for currency hedging purposes. Derivatives will not be used for investment purposes.

The Fund is considered to be actively managed in reference to the Bank of England's Base Rate by virtue of the fact that it aims to measure performance against the Index and to generate a return against the Bank of England's Base Rate plus 0.5% per annum on a rolling basis.

There is no geographical, industry or sectoral focus to the Fund.

You can buy and sell shares in the sub-fund on any week day on which commercial banks are open in Dublin and London.

This share class distributes quarterly dividends to Shareholders, if the Fund generates sufficient income.

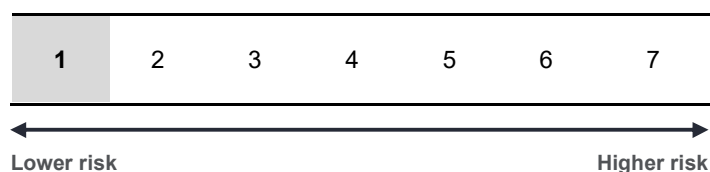

Intended retail investor:

The Fund is suitable for investors with a medium holding period and who have a low risk appetite.

What are the risks and what could I get in return?

Risk Indicator



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 1 out of 7, which is the lowest risk class. This rates the potential losses from future performance at a very low level, and poor market conditions are very unlikely to impact the ability for you to receive a positive return on your investment.

Be aware of currency risk. You will receive payments in a different currency, so the final return you will get depends on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.

Other key material risks not captured by the risk indicator that could potentially impact the Fund are disclosed in the Prospectus.

This product does not include any protection from future market performance so you could lose some or all of your investment.



The risk indicator assumes you keep the product for 5 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less.

Performance scenarios

The figures shown include all the costs of the product itself, but do not take into account your personal tax situation and may not include all the costs that you pay to your advisor or distributor, which may also affect how much you get back.

Unfavourable: This type of scenario occurred for an investment between February 2025 and February 2026.

What happens if the Manager is unable to pay out?

The Manager is responsible for administration and management of the ICAV and does not typically hold assets of the Fund (assets that can be held by depositary are, in line with applicable regulations, held with a depositary in its custody network). The Manager and the Investment Manager have no obligation to pay out since the Fund's design does not contemplate any such payment being made. However, investors may suffer loss if the ICAV or the depositary is unable to pay out. There is no public or private investor compensation scheme that can compensate for any losses due to the insolvency of the ICAV, the Manager and the Investment Manager.

What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed, in the first year you would get back the amount that you invested (0 % annual return). For the other holding period, we have assumed the fund performs as shown in the moderate scenario.
