

# TWP Blend Defensive

## Portfolio Objectives

Titan Square Mile aims to manage the model portfolio to an estimated volatility range between 5.9% and 7.5% p.a. over a market cycle. This is an estimation driven by capital market assumptions, and therefore not an annual guarantee as market movements may drive different outcomes in the shorter term. The Portfolio will be managed using Titan Square Mile's Growth 2 strategic asset allocation which has a 35% weight to equities. The portfolio will be invested in a mix of equities, fixed income and other defensive assets and the total equity exposure can range between 25% and 40%, at the time of investment. The portfolio may invest in funds managed by firms within the Titan Wealth Group. Square Mile Investment Services Limited is a wholly owned subsidiary of Titan Wealth Holdings Ltd, part of the Titan Wealth Group.

## Commentary

The final quarter of 2025 saw central banks pivoting toward rate cuts despite stubborn inflation, particularly from tariff pressures in the United States. Growth has softened markedly across developed markets, with unemployment rising and labour markets cooling. The Bank of England and the US Federal Reserve both cut interest rates, while the European Central Bank held rates steady and signalled a more cautious path ahead.

We maintained our more broadly diversified stance in our portfolios with typically 55% in equities, 25% in fixed interest and 20% in alternatives, where mandates allow in the Balanced portfolios as we believe that the future is likely to be accompanied by a more volatile market environment.

Equities outperformed bonds in the fourth quarter, thereby contributing the largest share of positive returns for our portfolios.

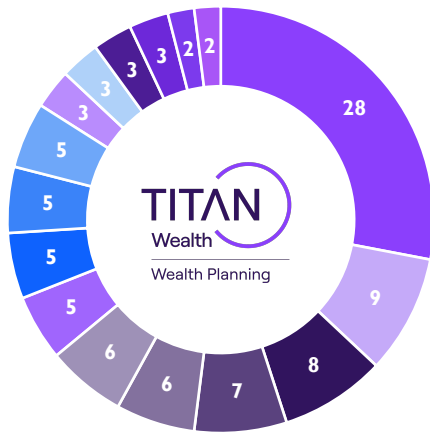
